

Terms

§ 1 General conditions

With us on the Camino, you can only buy through our website.

All goods remain Caminos (Getaware ekonomisk förening) property until full payment has been made the company. All attempts at fraud reported to the police. Camino reserves the right to cancel a purchase if fraud is suspected.

Camino reserves the possible "printing error" on this site. We can not guarantee that all pictures accurately reflect the true appearance. All prices include VAT, 6% on books and 25% on other goods.

Are you under 18, you must have parents permission to get to order from us.

§ 2 Payment and Delivery

We send all our packages to the Post. Products we have in stock are normally delivered within 7 days. At holiday times, however, the delivery time extended. Normally, goods are displayed in the shop in stock. However, we reserve for possible final sale. If a product is finished, you get a message about this, and when the product is expected to be in stock again.

For packages that are not picked up, you are charged a fee of SEK 200 per package to cover our costs for handling and return postage.

The products are sent as letters, packages or corporate packages, depending on weight and clients. Camino charges a fee for shipping and handling: currently SEK 36 per order.

Payment:

All prices on the website are listed including VAT. For payment we use PayPal - an internationally recognized and secure payment tools.

Transport Injuries:

Is the package and / or the contents damaged when you receive it, report it immediately to the site or to us. Have you opened the package and discover damage, contact us. When you return the goods to us you assume the risk of transportation.

§ 3 Right of withdrawal

For all the goods you have full right of withdrawal in 14 days from your receipt of goods. The goods must be unused and packed securely with any labels and price tags to go.

On your return or exchange of goods you pay own return shipping charges (and we will not refund any of our shipping costs). However, if there is a complaint because of damaged goods or that we have dispatched the wrong item we will refund you all freight costs while we will refund what you spent for the goods.

§ 4 Security

Secure pages:

All the pages where you as a customer leaves the personal details when purchasing so-called secure pages (encrypted transmission).

Secure payments:

Transfer of card data is encrypted. NOTE! Camino store any credit card numbers, but this is handled by PayPal.

§ 5 Personal Information

No customer information is disclosed to other parties.

You have the right to request access to the personal information about you. If they are inaccurate, incomplete or irrelevant you have the right to request that information be corrected or deleted.

§ 6 Force Majeure

Camino (Getaware ekonomisk förening) is exempt from penalty for failure to perform certain obligations under this Agreement if the failure is due to release factor as described below and the fact prevent, hinder or delay performance. As liberating circumstance shall be deemed to include authority's action or omission, new or amended legislation, industrial disputes, embargo, fire, flood, sabotage, accident, extend, or other type of natural disaster. The force majeure includes administrative decisions that affect the market negatively and products, such as restrictions in the indication, warnings, ban on sale, etc., an abnormal decline in the market and the company is exposed to criminal activity that affect the business.
